


Meet Dave Johnson, one of our Burnet County Volunteers

Dave Johnson has served a total of 6 children on 3 different cases through CASA since he took his first assignment in July of 2013. Dave completed his volunteer training in June of 2013 and jumped right in!!!!!

Dave does a great job working with his CASA kids. He has worked with all boys so far through CASA, ranging in age from 3 years old to teenagers, so if you have a question about how to help young boys, Dave might just have an answer!!!

Something you might not know about Dave, he's not originally from Texas. He grew up in New York and Pennsylvania and graduated from Purdue in Indiana! Before retiring from ExxonMobil he lived in Houston with his family, but Burnet is where he and his wife chose to retire! We are lucky to have him in the Highland Lakes Area!

When asked what made him decide to be a CASA advocate, Dave stated that his wife, Debbie, and he are blessed with 6 children and 9 grandchildren. Because of his family, he's had a lot of experience working with kids. He stated that he feels that our CASA kids are in tough situations through no fault of their own and should have the same kinds of opportunities that his own kids and grandkids have had. Dave feels that volunteering with CASA is one way to help children get to a better place in life and that, he says, is worth his time and effort. He adds that he had a lot of encouragement from a coworker of his in Houston, who was already volunteering as a CASA advocate.

When asked what the most surprising thing has been for him since volunteering with CASA, Dave states that he has been impressed by the extraordinary passion by all involved in the child welfare system - Judges, CPS workers, attorneys, counselors and CASA staff and volunteers!

One of her CASA kids is an infant with multiple medical issues and **Debbie** has accompanied the caregiver to numerous doctors appointments to help support the caregiver and ensure that the child's medical needs are met! Thank you, **Debbie Kane**, for your hard work and dedication to this child!
- Another applause is in order for **Keva Weir**, who has been working with a developmentally-delayed 3-year-old. **Keva** noticed early on in this case that the child might be delayed in speech and she advocated for an evaluation, despite others stating that the evaluation was not necessary. Because of **Keva Weir's** advocacy in this area, a hearing problem was diagnosed and this child is now getting necessary treatment in order to address the issue! Thanks, **Keva**! You have truly helped this child to have his hearing restored and his speech improved!!!!!
- Theresa Sivells is another volunteer particularly deserving of applause! Theresa is a graduate of our most recent volunteer training class and she has jumped right into her case! Theresa did an amazing job recently in advocating for therapy for her CASA kid. She went above and beyond by seeking out therapists in her child's area and helping to get this service set up. She made countless phone calls to help and her persistence is much appreciated!!!!
- One more round of applause this month to **Paula McGregor** who went with a CASA staff member on a Tour of Texas. This trip totaled more than 700 miles and while out on this tour **Paula** and our staff made 6 stops to visit with CASA kids and ensure that they are doing well. Thank you, **Paula**, for taking a trip to make sure our kids have what they need!
