#### A Letter from the Executive Director:

## CASA Wishes Hope and Strength to Flood and Tornado Victims and Child Victims of Abuse and Neglect

For many, Memorial Day Weekend signifies the beginning of summer, and summer in the Hill Country sure has gotten off to a tragic start. Our hearts go out to all of the flood and tornado victims across the country, but especially in the areas that we serve. Over Memorial Day Weekend rain was coming down in buckets, and storms were all around us. Blanco County, the southern-most county in our service area, received record amounts of rain, which swelled the Blanco River and caused a great deal of devastation for residents in and around Blanco County. While this was going on in the Blanco Area, Lampasas County, our northern-most county, was hit with a tornado that damaged several homes. It is tragedies like these that really put life into perspective and remind us of how fragile human life can be.

The Great Dalai Lama referenced a Tibetan saying when he reported "Tragedy should be utilized as a source of strength." Dalai Lama went on to state "No matter what sort of difficulties, how painful the experience is, if we lose our hope, that's our real disaster." Hope is rising in these areas of devastation as citizens rally together to support and comfort those needing help. Clean-up is underway and rebuilding might be slow, but I am certain that hope and determination will prevail.

Natural disasters, while trying and unfair, are not unlike what child victims of abuse and neglect endure. These children see disaster and devastation in their own homes on a very regular basis - so regularly that, to many children, these everyday disasters become normal to them. Then, when CPS comes in and removes the children from what the child views as "normal" the real disaster begins because the children are removed from what might be scary and devastating, but known, to what is unknown. Their whole world is turned upside down and most do not know how to react or recover. Like those assisting in Blanco and Lampasas Counties, our Volunteer Advocates serve as a light in the darkness for these kids. They provide hope to the hopeless so that hope is NOT lost and so that out of disaster can come strength and beauty.

To all of the flood and tornado victims out there - we are truly sorry for your losses and pray for hope to restore your strength. We at CASA for the Highland Lakes Area hope that each and every one of you have a safe and enjoyable rest of the summer.

He has been a CASA advocate for 2 years and has served 4 children on his own since starting with our program, but he also helps Susan with the many children that she works with. What made them decide to volunteer with CASA? Susan decided that volunteering with CASA was something she wanted to do after she retired in Dallas County. She reports that her daughter, who is a prosecutor,

told her more about CASA after Susan saw an ad for CASA volunteers in the Dallas News. The most surprising thing you've encountered as a CASA:

Susan says that she has been surprised and gratified at how highly the court values a CASA Advocate's opinion and also how some of the kids show so much more maturity than the adults in their lives. Soc has been most surprised by the resilience of the children and the dedication of the caregivers who are entrusted with the care of these kids.

Little known tidbits about this wonderful couple: Susan is a retired CPA and is involved with the community volunteer fire dept. She also loves to kayak and play MahJongg. Soc is retired, but enjoys part-time employment. He also enjoys a daily fitness routine, including sculling Lake LBJ. They also have 3 wonderful grandkids!

- We'd like to give a big round of applause to Mike Lubawski. Mike is currently advocating for 3 children on 2 separate CASA cases. One of these cases involves a young boy who needs weekly therapy and Mike transports this young boy to all of his therapy appointments and also keeps up with his other duties as a CASA advocate for these children! The child's therapist has found Mike to be extremely helpful because Mike has invested a lot of time into this case and knows a great deal about the history of the family and the current needs of his CASA kid. The foster mother greatly appreciates the support that **Mike** provides and this young boy is being forever changed in a very positive way by Mike's involvement and dedication! Let's give Mike Lubawski a big CASA Thank You!!!!!!
- Another round of applause is in order for **Juli Gilson**, who is doing a great job with her 3 CASA kids and has been advocating on behalf of these children regarding their placement. These 3 children were with a relative who could not continue to keep them and Juli worked hard to try to find the best alternative possible for these kids. She completed countless hours of research on out of state placements because relatives in Virginia wanted the children, but Virginia's regulations are much different from ours here in Texas and the process was delayed. Juli was able to advocate for this placement effectively in court because of all of her work and the children are now on their way to Virginia to be with relatives instead of moving into an unfamiliar foster home!!!! Juli also recently helped us with our CASA de Mayo retreat and she led the advocates in a group exercise regarding personalities and how to work with kids who have various personality types. Her presentation was both informative and enjoyable and we certainly appreciate all of the extra time she spends in making sure that our organization and our CASA kids are all well taken care of. Thank you, Juli!!!!!!
- We have one last applause, which is bittersweet. Many of you know Mance Bowden, who worked here at CASA for the Highland Lakes for some time and has continued to volunteer with us. We are happy for **Mance** because it was recently announced that he has been hired as the Executive Director for CASA of Bell and Coryell Counties. CASA Advocates, we have several new cases where the children are placed out of the area and there is no volunteer assigned to these cases at this time. If you are interested in taking a new case, or even if you normally travel to the locations listed below and can help us cover visits with these CASA kids, please let us know! The case information is as follows for these cases:

Blanco Case - 1 girl, age 4 - placed in Dickinson, TX

Burnet Case - 3 girls, ages 6, 10 and 12 - placed in Corpus Christi, TX

Burnet Case - 1 boy, age 6 and 1 girl, age 4 - placed in Lampasas

San Saba Case - 1 girl, age 1 month - placed in Luling, TX

Lampasas Case - 1 girl, age 13 - placed in Garland, TX

San Saba Case - 2 boys, ages 16 and 12 - placement is not yet known

San Saba Case - 2 boys, ages 3 and 5, placement is currently in Leander, but they may be moved to Houston
