## Honoring our Volunteer Advocates

On April 29th CASA staff and guests had the distinct privilege of honoring our advocates at our annual appreciation event. This year we held an appreciation dinner at Francesco's Restaurant in Marble Falls. The event was very enjoyable and everyone seemed to have a great time. Prior to special recognition awards I shared how many of Dr. Suess' most famous quotes are relatable to our wonderful volunteers.

One of Suess' most notable quotes applies to the generosity of our volunteers, which is "**Unless someone like you cares a whole awful lot, nothing is going to get better. It's not**". This one is pretty self-explanitory, but in all truth our volunteers care a great deal about their "CASA kids" and it is because of our wonderful advocates that the lives of these children have hope. CASA kids rely on their CASA volunteer to show them that there is a light, however faint it may be, and that they can continue to hope for a future.

Seuss also said "**Just tell yourself, Duckie, you're really quite lucky!**" And these kids are fortunate to have a CASA volunteer. Today in Texas only about half of the children in foster care have a CASA advocate assigned to their case. However, children from our 5 county area ARE lucky in that every child who enters into the child welfare system from our 5 county service area is assigned a CASA. It is unfortunate what these children are subjected to in their lives, but the presence of a CASA advocate helps them to never feel alone.

Today our program is covering 89% of our cases by volunteers. This is well above the 80% that is required by Texas and National CASA. While staff are able to handle the other 11% we know that children get more time and attention from CASA when there is a <u>volunteer</u> by their side. Because of this, our staff are committed to continuing to spread the word about CASA and we hope that community members will join us in this venture. Our goal is that every person in the Highland Lakes Area know about CASA and our mission. So tell everyone you know! Tell them about how CASA makes a difference in the life of a child. There is a quote in Horton Hears a Who that goes "We've got to make noises in greater amounts! So, open your mouth, lad! For every voice counts!!!" CASA voices DO count! CASA advocates ARE making a difference to the children they serve and to the community as a whole. Every time a CASA uses their voice in court they are making a huge difference in the life of a child.

All of our volunteers are truly inspiring and I just want everyone to know how much I mean that. CASA volunteers are selfless and go above and beyond for their CASA kids reminding us all that "a person's a person, no matter how small", another Dr. Suess quote. CASA volunteers are a great example of those who live to serve. Dr. Suess once said "Today I shall behave as if THIS is the day I will be remembered" and our volunteers will certainly be remembered because of the difference that they made in the lives of the children that they work with through CASA.

I speak for the entire staff at CASA when I say, we are forever grateful for our volunteers and for the voice that you provide for our children!





Our Advocates do amazing things each and every day. Here are just a few things that we at the CASA office have been amazed about over the past month!!!!!!!! Let's give each of these volunteers a great BIG round of APPLAUSE!!!!!!

- Our first applause goes out to **Dave Johnson**, our Advocate of the Year. **Dave Johnson** was recognized for his outstanding work as a CASA advocate at our recent appreciation dinner. **Dave** has touched the lives of every child that he has worked with through CASA, but his efforts with two teenage boys that he is currently advocating for were highlighted during the presentation of the Advocate of the Year Award. Both of these teenage boys have had a rough life and both see **Dave** as an advocate, a mentor and a friend. Each of these young men wrote **Dave** a letter, thanking him for helping them and congratulating him on being recognized as the Advocate of the Year. Within the letters, one of his CASA kids wrote "I would like you to know how thankful I am for you. Your kindness has given me the strength that only family can give. The advice and guidance you have given me will live in my memory for years to come....." Thank you, **Dave**, for your service to these young boys! We think the world of you, but even more importantly, it is evident that your CASA kids do too!!!!!
- Our next applause goes out to **Jay Carey**. **Jay** is a fierce advocate and, like all of our advocates, he only wants what is best for his CASA kids. **Jay** has been visiting with one of the teenage boys that he is working with through CASA and felt that his caregivers were not providing him with the guidance and structure that he needs in order to be successful. **Jay** felt strongly about this and about the ability of the system to find a better place for this young man. He was the only person involved in the case that felt strongly that this young man should be moved to another home and **Jay** did a great job of articulating his concerns to the Judge. Ultimately the Judge realized exactly what the concern was and agreed that this young man could achieve his potential more successfully in a new home. Now **Jay** is working with the attorney for the child and the CPS worker to ensure that the best possible foster home is found so that this young man can grow into a successful adult. Thank you, **Jay**, for remaining firm and advocating for what you know is best for this young man!
- Our last applause goes out to **Dave Hartig**, an advocate who was recognized at the appreciation dinner for being the best CASA Ambassador! **Dave** does an amazing job with the children that he is appointed to represent, but he also helps us here at the office by making sure that everyone he knows understands what CASA is and how they can help. **Dave** has made a difference in the lives of the children that he works with through our program, but he does not stop there! He also enables us to make a difference in the lives of countless children because he helps to spread the CASA mission and gather more support for our program. We appreciate this very much, **Dave**, and we are so blessed to have you as part of our wonderful team!!!!
