THE MISSION OF CASA FOR THE HIGHLAND LAKES AREA IS TO RECRUIT, TRAIN AND SUPERVISE COURT APPOINTED VOLUNTEER ADVOCATES FOR CHILDREN WHO COME INTO THE COURT SYSTEM AS A RESULT OF ABUSE AND/OR NEGLECT IN BURNET, BLANCO, LLANO, LAMPASAS, AND SAN SABA COUNTIES. THOSE VOLUNTEER ADVOCATES, WHO SERVE AS GUARDIANS AD LITEM, WILL MAKE RECOMMENDATIONS TO THE COURT, BASED ON FACT FINDING AND INVESTIGATION, IN THE BEST INTEREST OF THE CHILD.

WE PROVIDE A LIFELINE FOR OUR CASA CHILDREN BY HELPING THEM NAVIGATE THE FOSTER CARE SYSTEM, UNTIL THEY ARE RETURNED HOME AND REUNITED WITH THEIR FAMILY, OR ARE ADOPTED BY A NEW FOREVER FAMILY.

Dear Friend of CASA,

We are thrilled to announce to you the date and details for our upcoming annual Boots and BBQ. This event is the largest fundraising source for CASA for the Highland Lakes Area and allows us to provide a voice to the most vulnerable children in our community. We are the only organization that can provide our children with what they need at the most critical time in their lives - a volunteer who will fight for and help assure their safe passage through childhood into adulthood. This exciting and much-anticipated event will take place at Horseshoe Bay Resort on Saturday, February 3<sup>RD</sup>.

Imagine what it would be like to lose your parents, not because of something you did, but because they cannot - or will not - take care of you. Now, into these children's lives come dozens of strangers: police, foster parents, therapists, social workers, judges, lawyers and more. Hopefully one of these strangers is a CASA (Court Appointed Special Advocate) volunteer.

We believe every child deserves to have a dedicated advocate speaking up for their best interest in court, at school, and in our community. To accomplish this, we educate and empower diverse community volunteers who ensure each child's needs remain a priority in an overburdened child welfare system. When the state steps in to protect a child's safety because the people responsible for protecting them have not, a judge appoints a trained volunteer advocate to make independent and informed recommendations and help that judge decide what is best for the child.

For many children, their CASA volunteer will be the one constant adult presence - the one adult who cares only for their best interest- during their entire time in foster care. Since our inception in 1991, we have served over 5300 children with over 450 volunteers. While we are now serving more than 300 children each year with over 80 active volunteers.

As a **sponsor** of Boots & BBQ, you become a powerful voice in the life of an abused or neglected child who needs a CASA advocate by their side. Corporate, foundation, and individual funding are used to serve and protect children in crisis. Highland Lakes' CASA volunteers are making a difference in children's lives every day.
